It seems the CAS does and will require all foster children to be vaccinated according to Public health's recommendations. Foster homes that chose not to vaccinate their legal children have the right to do so; however there will be times that specific foster children may not be placed in homes where the legal children of the foster family have not been vaccinated due to the understanding of specific risks to those children. There is no indication the at CAS will not open foster homes who do not vaccinate, and no indication of the CAS pulling children or closing homes due to a choice not to vaccinate. This is based on responses of those who replied to the question.

Charitable status

- Following the **positive** response from the CRA regarding our charitable status, FPSO this month transacted the process of a membership vote regarding the Letters of Patent.
- The call for the vote with all accompanying documentation went out on the 15th of June.
- The numbers of participants in the vote completed the requirement of a special resolution and all were unanimously affirmative to make the prescribed changes to the letters of patent. This was complete by the 28th of June
- The process of forwarding these documents to the authorized authorities in the province has been completed. We now again wait for further response.

 - Standardizing the foster care per diem rates for foster parents and reimbursable amounts for the children in care across the Province based on the Toronto CAST model.
